



Maine Electronic Waste Recycling Program Manufacturer Registration for Calendar Year 2025

Maine's *Electronic Waste* Law, 38 M.R.S.A. §1610, requires manufacturers of certain electronics to register annually with the Maine Department of Environmental Protection (DEP) by April 1.

Who must register?

Current manufacturers of covered electronic devices (for a full list of devices see "What products need to be registered?" below).

"Manufacturer" means a person who:

- (1) Manufactures or has manufactured a covered electronic device under its own brand or label;
- (2) Sells or has sold under its own brand or label a covered electronic device produced by other suppliers;
- (3) Imports or has imported a covered electronic device into the United States that is manufactured by a person without a presence in the United States; or
- (4) Owns a brand that it licenses or licensed to another person for use on a covered electronic device.

What is the registration fee?

Annual registration fees are \$3000 or \$750, depending on product sales. By March 1st of each year, the DEP will send invoices to manufacturers that have previously registered with us.

Manufacturers registering for the first time will receive invoices once they submit a completed registration form.

What product types need to be registered?

Maine law requires the registration of the following products:

- Printers: weighing 100 pounds or less; includes 3D printers
- Video game consoles: an interactive entertainment computer or electronic device that produces a video display signal that can be used with a display device
- Televisions: video display devices measuring at least 4" diagonally that can receive a broadcast signal; includes portable DVD players and surveillance systems with screens measuring at least 4" diagonally
- Other video display devices with a screen that is greater than 4 inches measured diagonally and that contain one or more circuit boards, including monitors, all-in-one computers, tablets, laptops, digital picture frames, e-readers, GPS screens, etc.
